### **Shareholder Update: Voting Reminder**

Thorn Group Limited (ASX: TGA) (**Thorn**) refers to the Notice of Extraordinary General Meeting (**Notice of Meeting**) issued to the ASX on 28 October 2020.

The Extraordinary General Meeting (**Meeting**) will be held at Thursday 3 December 2020 at 11:30am (Sydney time). Due to the COVID-19 pandemic, in the interests of the health and safety of the Company's shareholders and staff, the Meeting will be held virtually (online).

Following queries to the Company, we wish to provide the following reminders:

- 1) The consequences of a vote each way are detailed below:
  - A vote in **favour** of the resolutions will change the current Board of Directors;
  - A vote **AGAINST** will leave the current Board of Directors as it is.
- 2) If you wish to support the current Board of Directors, you need to vote <u>AGAINST</u> all five proposed resolutions put forward in the Notice.
- 3) The Chair of the Meeting (Mr Paul Oneile, Thorn's independent non-executive director) does not support the proposed resolutions and proposes to vote <u>AGAINST</u> all resolutions. The Chair intends to vote all available undirected proxies <u>AGAINST</u> each resolution.
- 4) If any shareholders wish to change a vote, you can do so by simply re-casting your vote online. The most recent vote will replace any vote previously made/received.

It is highly encouraged that you vote on the resolutions contained in the Notice of Meeting, your vote will determine the future of Thorn.

### Voting by Proxy before the Meeting

The Company encourages those shareholders who are intending to vote on the resolutions being put forward at the Meeting to submit their vote ahead of time.
