

# Thorn Group Limited (ASX:TGA) Quarterly Activities Report to 30 September 2020

**Sydney, 30 October 2020:** Thorn Group Limited (ASX:TGA) ("Thorn") presents the following review on the key business activities for the quarter ending 30 September 2020 and material events post the end of the period. Thorn is pleased to report on a productive quarter in which Thorn has further advanced key optimisation initiatives and cost reduction opportunities during challenging circumstances as a result of the COVID-19 pandemic.

## **Principal activities**

Thorn is a diversified financial services group providing leasing of household products to consumers and commercial asset finance to small and medium enterprises.

# Key areas of activity during the quarter ending 30 September 2020

Thorn held its Annual General Meeting on 19 August 2020.

Thorn's directors and management continued to develop and enact measures to respond to the COVID-19 pandemic threat and its impact on the Company's operations.

Thorn's Radio Rentals' business launched a new purely online model, www.radio-rentals.com.au. The business has been transformed from a store-based business model supported by internal warehousing and logistics, to a digital originations model utilising drop-ship partners, and centralising key functions to reduce costs and improve collections capability.

The Business Finance division, while continuing to face adverse business conditions, has seen some improvements with cash collections up circa 20% on the previous quarter as many of those affected by the pandemic resumed payments. This has been achieved by increasing the use of technology, utilisation of data and analytics to prioritise appropriate collection activities, implementation of training programs to improve customer conversations outcomes and disciplined use of third parties to assist with collection activities and a focus on post write off recovery activity.

While the Thorn Business Finance warehouse funding facility remains in amortisation, agreement has been reached with the facility providers on payment holidays offered to, and the recommencement of payments from, eligible customers adversely affected by the pandemic.

# Commentary on the Appendix 4C Cash Flow report

• Thorn recorded a positive cash flow of \$53.9 million from its operating activities as the inflow of receipts from previously written leasing contracts exceeded both operating expenses and the origination of new contracts in the present circumstances.



- \$36.2 million of warehouse debt funding was repaid along with \$10 million of the corporate debt facility.
- The cash balance at the quarter end increased from \$71.8m million (as at 30 June 2020) to \$79.5 million. The cash balance includes both free cash and the tied cash in the warehouse funding trust. Free cash at the end of the period was \$60.7 million.
- \$1.35 million of JobKeeper payments were received.

### **Next Two Quarters Activity**

- Thorn will pay a special fully franked dividend of 7.5 cents per share on 3 November 2020. Thorn's dividend reinvestment plan (DRP) will apply to the special dividend.
- Thorn will continue to monitor developments relating to COVID-19 along with guidelines introduced by Federal and State Governments and the health authorities.
- Thorn's remote working protocols for its staff will remain in place whilst COVID-19 remains a concern.
- The focus of the Radio Rentals business is on extending the range, digitising and automating processes to reduce "cost to serve" and delivering leading customer experiences.
- Thorn is expected to finalise the completion of the Radio Rentals store lease exit program.
- The pandemic has affected the financial position of many of Thorn's small and medium enterprise
  customers and we will continue to work with these customers on finalising contract variations and
  further remediation.
- Thorn will continue to actively pursue productivity improvements.
- Thorn will continue to upgrade, streamline and automate its underwriting processes.
- Thorn will release its half yearly financial statements for the period ended 30 September 2020 on 27 November 2020.
- An extraordinary general meeting will be held on 3 December 2020.

The loan facilities consist of two items; a securitised warehouse facility used to finance equipment leasing, and a corporate facility used to finance consumer leasing and which is divided into an A and a B facility.

The securitised warehouse facility is currently in amortisation and no further funding drawdown is available while it remains in amortisation. Therefore it is fully drawn at \$236.0m. The amount is secured over the receivables in the warehouse. The identity of lenders and the interest rate details are withheld.

The corporate loan facility A was fully repaid during the quarter (\$10m drawn at end of previous quarter) and formally closed in October 2020.

The corporate loan facility B is used for bank guarantees and an overdraft, is secured, and the identity of the lender and the interest rate details are withheld. At the quarter end it was drawn to circa \$1.9m for bank guarantees provided to landlords on property rental bonds and is considered to be fully drawn at the moment.
