

Extraordinary General Meeting

Thorn Group Limited (ASX: TGA) (**Thorn**) refers to the ASX announcement on 17 December 2020 containing a media release from the Takeovers Panel concerning the outcome of the *Thorn Group Limited 01 & 02* proceedings and setting out a summary of the Takeovers Panel's final orders in those proceedings (**Orders**).

The Takeovers Panel has ordered that the extraordinary general meeting of Thorn adjourned on 3 December 2020 (**EGM**) be resumed on or after Monday, 4 January 2021 and in any event no later than noon on Friday, 15 January 2021.

In accordance with the Orders, Thorn gives notice that the EGM will be resumed on the date, and at the time, listed below:

VOTING BY PROXY

The instructions for voting by proxy at the EGM are set out in the Notice of EGM except that, consistent with the requirements of its constitution and section 250B(2) of the *Corporations Act 2001* (Cth), the deadline for the receipt of proxy forms has been extended to no later than 11.30am (Sydney time) on 2 January 2021.

SHAREHOLDERS WHO ARE ENTITLED TO VOTE

For the purposes of the EGM and in accordance with regulation 7.11.37 of the *Corporations Regulations 2001*, a person is entitled to vote at the EGM if that person was registered as a holder of Thorn's shares in the register of shareholders of Thorn as at 7.00pm (Sydney time) on Wednesday, 2 December 2020, being the record date for voting at the EGM that was originally scheduled for 3 December 2020
